The Undersigned Hereby Releases, Waives, Discharges and Covenants Not to Sue Northampton County Parks and Recreation Department (NCPR), its past, current or future officers, directors, administrators, agents, and assigns, the Tournament sponsor(s), Northampton County, Northampton County Parks and Recreation Department, their past, current or future officers, directors, administrators, agents, and employees, and/or the school alumni association or local chapter on whose team I participate (hereinafter collectively referred to as "Releases") from all liability, and any claim or demands there under, on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the Releasees or otherwise, while the undersigned is in any way participating in the League, including, but not limited to playing in or observing League games, using League equipment, and/or being involved in the League in any way.

The Undersigned Hereby Agrees to Indemnify and Save and Hold Harmless the Releasees from any loss, liability, damage or cost they may incur due to the participation of the undersigned in the League, whether caused by the negligence of the Releasees or otherwise.

The Undersigned Acknowledges that she/he understands and Assumes Full Responsibility for the Risk of Bodily Injury, Death, or Property Damage due to the negligence of Releasees or otherwise while playing in or observing League games, using League equipment, and/or being involved in the League in any way.

The Undersigned further expressly agrees that the foregoing Release, Waiver, and indemnity Agreement is intended to be as broad and inclusive as is permitted by the law, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The Undersigned Has Read, Understood and Voluntarily, without any coercion whatsoever, Signs the Release and Waiver of Liability and Indemnity Agreement, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
